The panel Ms. Nearing participated on focused on the impact of the Committee on Foreign Investment in the United States ("CFIUS") on cross-border investments and deal making. Fellow panelists included Jeff Farra, Vice President, Government Affairs, **National Venture Capital Association (NVCA)**; Joseph Benkert, Senior Advisor, **Morrison & Foerster LLP**; and Jun Bao, Ph.D., MBA, President and CEO, **IMPACT Therapeutics**. One of the key take aways from the discussion is that regulatory reform is causing concern and pause on the part of many China-based investors and uncertainty by both investors and

early-stage biotech's in the US that relies on these funds. It's unlikely these investments would stop altogether, it is very possible that these investments will go to other countries (including Europe) and or other industries.

**Nareg Sagherian, Director, Biotechnology Innovation Organization** said, "BIO's conference audience greatly benefited from Kim's experienced perspective on the priorities of life sciences investors in China and her ability to summarize current concerns among deal makers interested in cross-border investing.
